MithSamlanh was established in August 1994 and is a Cambodian led non-government organization committed to working with marginalized Cambodian children and youth, their families and communities. MithSamlanh was formally registered as a local Cambodian NGO in 2002. Every year, MithSamlanh provides various outreach programs, vocational training, education, counselling, food, shelter, medical services and income generation programs to 15,000 marginalized children, youth and families in Phnom Penh.

Together, we protect marginalized children/youth and related groups and with them create innovative and exciting opportunities to build their futures.

MithSamlanh is a local non-Governmental organization, founded by Friends-International and a member of the CYTI Alliance, which works with and for marginalized children, youth, their families and their communities to build their futures.

### MITH SAMLANH'S ACHIEVEMENTS IN 2015

- 8,356(F: 3,104) children and youth and 3,442 (F: 1,838) caretakers received services in Phnom Penh and Provinces since 1<sup>st</sup> January 2015.
- 775,816 (F: 262,055) services were provided to children, youth and their caretakers in this quarter and 2,053,581 (F: 704,090) since 1<sup>st</sup> January 2015
- 710(F: 226) children and youth were supported to move away from the street life by accessing education, vocational training and detoxification since 1<sup>st</sup> January 2015.
- 386(F: 173) children received remedial education since 1<sup>st</sup> January 2015
- 102 (F: 42) new children were supported to reintegrate into public school since 1<sup>st</sup> January 2015
- 978 (F:463) children have received support to remain in public school. Of these, 124(F:54) no longer receive support because they are successfully supported by their families and 191 (F:80) for other reasons such as referred to other NGOs, lost contact, moved to other location since 1<sup>st</sup> January 2015
- 470(F:123) youth received vocational training and 77 (F:35) were supported for apprenticeship since 1<sup>st</sup> January 2015
- 146 (F:47) youth were placed into employment (employment, self-employment, directly into employment, find job by themselves and after apprenticeship) in Phnom Penh and Provinces since 1<sup>st</sup> January 2015

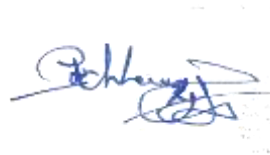
